Final draft of by-laws was submitted by the adhoc purpose/vision restructuring committee. Sense of the meeting was that GPQM has received proposed by-laws and policies and procedures from adhoc-committee. Any changes will be submitted to clerk and officers by November 30 with intent for approval at May meeting.

  - perhaps include in by-laws that GPQM may choose to be involved with other organizations
  - initial paragraph describes purpose; specifics about relationships belongs in a different document
  - what are limitations of by-laws and policies and procedures in regard to GPQM relationships with other organizations?
  - relationship between MFC and GPQM needs homework before next meeting
  - come to spirit of agreement about the by-laws for next meeting
